#### **Course Objectives**

This course will cover the development of international organizations during the 20<sup>th</sup> century. The thinking associated with international organizations as a phenomenon of state-to-state cooperation will be examined. Primary emphasis will be given to the United Nations, along with other international organizations such as the international financial institutions.

Students who complete the course will finish with an understanding of the theory and role of international organizations in international relations, a strong background in how the United Nations and associated international financial institutions have evolved and operated since World War II, as well as an awareness of the major issues facing international organizations generally in the current political environment.

## Research Paper Proposal

Due date for outline: 23 October

Students are required to write a 15-page research paper (double-spaced, 12 point font, 3,750 words). The topic should be related to the International Organization you chose from the list above, and take one of the themes below as a starting point for analysis. The exact topic is to be agreed in consultation with the instructor by email or phone.

After students develop their topic in consultation with the professor, they will submit a research paper proposal, which establishes the question to be answered, outlines the way in which you will answer it and provides a brief bibliography.

The proposal is worth 10% of the total final grade. Length 1-2 double spaced pages not including the bibliography.

## Research Paper

## Due date for final paper: 20 November

The second deliverable is the research paper itself. This worth 30% of the total final grade.

The research paper should examine your international organization in the context of a specific issue.

## Take Home Final Exam, 6-7 December

The final exam will be an open book take home exam. The questions will be posted on Moodle on 6 December. The responses must be submitted via Moodle before midnight on 7 December.
